In consideration of the use of the premises, facilities and services of Lightspeed Entertainment Inc. ("27 Social") I, an adult visitor (eighteen years age or older) or the parent or legally appointed guardian ("Parent") of a visitor who is a minor ("Minor"), understand, acknowledge and agree as follows:

Facility and Activities: 27 Social is located at 4251 S. 27th Street, Greenfield, WI 53221 (the "Facility"). I understand that the activities offered by 27 Social include engaging in gaming attractions including Go Karts, Laser Tag, Football Bowling, Axe Throwing, Table and Arcade Games, Consuming Food and/or Beverages, and otherwise moving about the Facility premises and its outside perimeter ("Activities")

Risks: I understand that the activities require moderate to heavy physical exertion and represent that neither I nor the Minor (if Applicable) has any mental or physical condition that might create risk to myself (or the Minor), or to others. I understand the Activities of 27 Social are dangerous and that visitors will be exposed to risks including among others the following (1) Slips, falls or collisions. (2) Misuse of equipment. (3) Failure of equipment, including worn or defective safety equipment. (4) My (or the Minor's) physical strength, coordination, sense of balance while participating. (5) Bad decision making by me (or the minor) or by other participants (6) acts or omissions of other people, including staff, which might include inadequate or faulty instructions. **These Risks and others not listed are inherent to 27 Social, its activities and premises; They cannot be eliminated without destroying the basic nature of a visit to 27 Social and participation in its activities.**

Assumption of Risks: I understand that the risks described above, and others, inherent or not, may result in all manner of trauma including breaks, sprains, abrasions, cuts, serious injury, and even death. I acknowledge and assume all risks, inherent and otherwise, whether or not described above. I will carefully read and comply with the guidelines, warnings, and instructional signage of 27 Social. If the visitor is a Minor, I, Parent have discussed the guidelines, activities and risks with the minor who understands them and wishes to participate nevertheless.

Release & Indemnity I for myself or on behalf of the minor accept full responsibility for any personal injury which pay result from my participation in the Activity, and I hereby HOLD HARMLESS 27 Social, Lightspeed Entertainment, and any of its employees for any personal injury or death sustained my me or the minor that may be caused by the negligence of 27 Social, Lightspeed Entertainment, and any of its employees while participating in the Activity. I agree not to bring any lawsuit against 27 Social, Lightspeed Entertainment, and any of its employees for any injury caused by the negligence of 27 Social, Lightspeed Entertainment, and any of its employees.

I AGREE that the Release of Liability, Waiver and Assumption of Risk will be governed by the Laws of the State of Wisconsin and that any dispute arising from this Release of Liability, Waiver and Assumption of Risk will be adjudicated by the State of Wisconsin. Any suit or mediation of any dispute will take place solely in Milwaukee County, Wisconsin. I consent to the jurisdiction of such courts, for myself or on behalf of the Minor.

This document is intended to be binding to the fullest extent of the law. If any part of this document is deemed to be unenforceable the remainder shall nevertheless be in full force and effect.

I hereby give 27 Social and Lightspeed Entertainment Inc. my permission and consent to take photographs, video, and other images of me or the Minor and use the images in our marketing and promotions without compensation. I forever release and hold harmless 27 Social and Lightspeed Entertainment from any and all claims or causes of action related to the use of the images.

I HAVE READ AND FULLY UNDERSTOOD THIS FORM AND AGREE TO BE BOUND BY IT DURING THIS AND ALL SUBSEQUENT VISITS TO 27 SOCIAL. I am aware that by signing this Release of Liability, I am waiving certain legal rights including the right to sue Lightspeed Entertainment Inc. its owners, officers, or employees for negligent acts or omissions.
